

CLUBHOUSE RENTAL APPLICATION

The use of the Clubhouse and its facilities is limited to residents and guests who accompany them. The use of the second floor lounge and bar area is not included in any rental.

Everyone using the Clubhouse will be required to sign his or her name in the Guest Log. Only those residents in good standing who are the legal owners or leaseholder of record are permitted to use the Clubhouse. Tenants of an owner or lessee are not permitted to rent the Clubhouse and cannot use the Clubhouse unless accompanied by an owner or lease holder of record. It is the policy of Montauk Shores not to rent the Clubhouse for private parties between Memorial Day and Labor Day. However, the Clubhouse is available at most other times throughout the year to be rented for private parties and other special occasions.

The fee for renting the Clubhouse is FIFTY (\$50.00) DOLLARS, which is for the use of the downstairs recreation area only. The upstairs lounge area cannot be rented for a private function. In addition, a refundable security deposit in the amount of TWO HUNDRED AND FIFTY (\$250.00) DOLLARS must accompany the rental fee, together with the completed Clubhouse Rental Application, and be delivered to Montauk Shores Condominium at least FOURTEEN (14) DAYS prior to the proposed rental date of the Clubhouse. Please make all checks payable to Montauk Shores Condominium. You will be responsible for the cleanup after the party and the security deposit will be returned to you provided the Clubhouse is left in the same condition as it was found. Depending on the size and type of event, Montauk Shores may require an employee to be present during the rental period who will be available to assist with any questions you may have. However, the employee will not be responsible to perform any tasks for you.

The Clubhouse, being for private and exclusive use of our residents and their guests, is not a licensed premise for the sale of alcoholic beverages. Providing doing so does not violate the laws governing dispensing of alcoholic beverages you are permitted to serve your guests alcoholic beverages. The information regarding the providing of alcoholic beverages will be required as part of your application for the rental.
